NOTIFICATION

No.1(5)/2007Pers.I: In pursuance of the Information Technology ( Amendment ) Act, 2008 enforced vide Gazette Notification no. S.O. 2689(E) dated 27.10.2009 and Recruitment Rules thereof notified vide Gazette Notification no. G.S.R. 556(E) dated 27.07.2009, Central Government hereby effects the following changes :-

- i) The Indian Computer Emergency Response Team earlier known as Computer Emergency Response Team - India (CERT-In) shall serve as the nodal agency in the area of cyber security ;
- ii) The post of Director shall now be read as "Director General".

2. In view of above, the post of Director ( CERT-In ) held by Dr. Gulshan Rai (on deputation basis w.e.f. 10.06.2008 for a period of three years ) has been re-designated as Director General, Indian Computer Emergency Response Team. He will continue to hold the post of Director General on deputation for the remaining period as mentioned in the Notification dated 13.06.2009.
