### OFFICE ORDER

Subject: The Delegation of Powers to the Indian Computer Emergency Response Team (ICERT), a Statutory Body of Department of Electronics & Information Technology (Deity)- reg.

The Director General, ICERT has been declared as Head of Department under Rule 3(f) of the Delegation of Financial Powers Rules (DFPR) vide Order No.17(04)/2013 Pers.I dated 12<sup>th</sup> March, 2013 and Smt. Savita Utreja, Scientist 'F' has been designated to function as Assistant Financial Adviser for ICERT vide Office Order No.17(04)/2013-Pers.I dated 9<sup>th</sup> May, 2013.

- 2. Further, as per provisions under Rule 13 of DFPR and as per Department of Expenditure's OM No.1/7/E.II(A)/2008 dated 30<sup>th</sup> May 2008, the Departments of the Central Government have been allowed to decide the extent of financial powers that may be delegated to Heads of Departments, clearly laying down the financial limits where consultation with Financial Adviser in the Ministry/Department, would not be required for exercising the financial powers so delegated.
- 3. In pursuance of these instructions, it has now been decided to delegate financial powers to DG, ICERT in respect of Contingent Expenditure and other items as given in **Annexure I to III** as enclosed.
- 4. It has also been decided to delegate financial powers in respect of items of work not falling under the categories of Contingent & Miscellaneous Expenditure and those not covered in Schedule V and Schedule VI of the DFPRs. Such items of work having financial implications, and are covered under various instructions contained in the GFRs, GPF Rules, Fundamental Rules and CS(MA) Rules have been delegated to the extent mentioned in the enclosed statement at items Nos. 1.2 to 6.1.
- 5. The proposals in respect of items not covered under the enclosed statement (Annexures) and requiring financial concurrence, such proposals would continue to be referred to IFD, DeitY, through the Cyber Law & e-Security Group. Also proposals which are in relaxation of the prescribed norms/relevant rules would be referred through Cyber Law & e-Security Group.
